CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the Town of Portsmouth and the National Education Association Rhode Island

Town Clerk, Canvassing Auth. Reg., Benefits Admin./Coor., but excluding the Town Admin., Personnel/Finance Dir., Exec. Sec. to the Planning Bd., Exec. Sec. to the Town Admin., Tax Assessor/Collector, Dir. of P.W. and Town Clerk.

On the basis of the election of said employees as aforesaid, the National Education Association Rhode Island

has been designated by a majority of said employees of the Town of Portsmouth as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 6, of the Rhode Island State Labor Relations Act, Chapter 1066 of the Public Laws of 1941, as amended, it is hereby:

CERTIFIED, that the National Education Association Rhode Island has been designated and selected by a majority of the (SEE ABOVE FOR UNIT)

as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 6, subdivision 1, of the Act, the National Education Association Rhode Island

is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
