"Accounting Supervisor, Administrative Secretary (Utilities) & (Police), Beach Manager, Building Inspection & Maintenance Supervisor, Computer Manager (Police), Computer Programmer, Deputy Zoning Officer, Engineering Supervisor, Equipment Maintenance Supervisor, Junior Accountant, Laboratory Chemist, Laboratory Supervisor, Microbiologist, Planner, Public Works Supervisor, Purchasing Agent, Recreation Program Supervisor, Research & Development Administrator (Police), Senior Development Planner, Sewer Maintenance Supervisor (Sewer Collection Systems Supervisor), Solid Waste Coordinator (20 hours per week), Deputy Tax Assessor, Water Distribution & Collection Supervisor, Water Meter Supervisor, Municipal Court Clerk,"

and shall exclude the following positions:

"Administrative Assistant (Manager's Office), Financial Analyst, Collection Supervisor, City Clerk, Controller, Data Processing Administrator, City Treasurer, Deputy Utilities Director, Director of Finance, Director Planning Zoning & Development, Director Public Works, Executive Assistant (Manager's Office), Trees & Grounds Supervisor, Personnel Administrator, Property Records Supervisor/Deputy Clerk, Recreation Administrator, Sewage Plant Pumping Supervisor, Utilities Director, Water Quality & Production Supervisor, Zoning Officer, Tax Assessor, Administrative Assistant to Solicitor, Director Parks, Recreation & Tourism."
