CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between Rhode Island Public Transit Authority (Relief Superintendent, Mechanical Foreman, Utility Foreman, Buildings & Grounds Foreman, Body Shop Foreman, Dispatcher/Street Supervisor, Assistant Superintendent, Manager of Inventory Control, Night Foreman, Instructor, Technical Support Officer/Research & Development, and Technical Support Officer/Training) and Division 618A - Amalgamated Transit Union, AFL-CIO - CLC, the Rhode Island State Labor Relations Board held an election on May 6, 1997 by Comparison of Signatures of: Relief Superintendent, Mechanical Foreman, Utility Foreman, Buildings & Grounds Foreman, Body Shop Foreman, Dispatcher/Street Supervisor, Assistant Superintendent, Manager of Inventory Control, Night Foreman, Instructor, Technical Support Officer/Research & Development, and Technical Support Officer/Training, employed by the Rhode Island Public Transit Authority.

On the basis of the Comparison of Signatures of said employees as afore-said, Division 618A - Amalgamated Transit Union, AFL-CIO - CLC has been designated by a majority of said employees of the Rhode Island Public Transit Authority (Relief Superintendent, Mechanical Foreman, Utility Foreman, Buildings & Grounds Foreman, Body Shop Foreman, Dispatcher/Street Supervisor, Assistant Superintendent, Manager of Inventory Control, Night Foreman, Instructor, Technical Support Officer/Research & Development, and Technical Support Officer/Training) as their collective bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that Division 618A - Amalgamated Transit Union, AFL-CIO - CLC has been designated and selected by a majority of: Relief Superintendent, Mechanical Foreman, Utility Foreman, Buildings & Grounds Foreman, Body Shop Foreman, Dispatcher/Street Supervisor, Assistant Superintendent, Manager of Inventory Control, Night Foreman, Instruction, Technical Support Officer/Research & Development, and Technical Support Officer/Training, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 28-7-16 of the Act, Division 618A - Amalgamated Transit Union, AFL-CIO - CLC is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
