AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – University of Rhode Island Board of Trustees - URI** and **RI Council 94, AFSCME, AFL-CIO, Local 2877-1**, the Rhode Island State Labor Relations Board held an election on March 24, 2003, by secret ballot of: Chief Mate, Mate, Bos’n, Able-Bodied Seamen, 3<sup>rd</sup> Assistant Engineer, Oiler, Steward/Cook, and Cook/Messman, excluding the Captain, Chief Engineer, and Marine Supervisor.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2877-1** has been designated by a majority of said employees of the **State of Rhode Island – University of Rhode Island Board of Trustees - URI** as their bargaining representative.

That on April 16, 2020, a request was received from RI Council 94, AFSCME, AFL-CIO that the above-entitled certification be amended to reflect the identity change of the party’s representatives.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party’s representatives, to read: **State of Rhode Island – University of Rhode Island Board of Trustees – URI** and **RI Council 94, AFSCME, AFL-CIO, Local 2877-1**.

**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

**CERTIFIED**, that **RI Council 94, AFSCME, AFL-CIO, Local 2877-1** has been designated and selected by a majority of: Chief Mate, Mate, Bos’n, Able-Bodied Seamen, 3<sup>rd</sup> Assistant Engineer, Oiler, Steward/Cook, and Cook/Messman, excluding the Captain, Chief Engineer, and Marine Supervisor, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2877-1** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
