AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the Town of New Shoreham and the Block Island Policeman's Association, the Rhode Island State Labor Relations Board held an election on July 23, 2003, by secret ballot of all full-time Police Officers except the Chief of Police.

On the basis of the Comparison of Signatures of said employees as aforesaid, the Block Island Policeman's Association had been designated by a majority of said employees of the Town of New Shoreham, as their collective bargaining representative.

On October 27, 2008, the International Brotherhood of Police Officers (IBPO) filed a Petition for Affiliation/Merger with the RI State Labor Relations Board. In accordance with the RI State Labor Relations Board's Rules and Regulations, Section 8.07, Affiliation/Merger, a notice was posted for said meeting and vote to affiliate/merge with International Brotherhood of Police Officers (IBPO) by the Block Island Policeman's Association.; thus, resulting in a majority vote to affiliate/merge with the International Brotherhood of Police Officers (IBPO).

On November 18, 2008, after submission of all the appropriate documentation, the RI State Labor Relations Board accepted the Consent Agreement and Affidavit for the affiliation/merger of the Block Island Policeman's Association into the International Brotherhood of Police Officers (IBPO).

**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

**CERTIFIED**, that **the International Brotherhood of Police Officers (IBPO)**, has been designated and selected by a majority of employees to include: **All full-time police officers except the Chief of Police**, to act as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of 28-7-16 of the Act, **the International Brotherhood of Police Officers (IBPO)**, is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
