AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the Town of Jamestown, Water Department, Service Employees International Union, AFL-CIO, Local 134, and United Service & Allied Workers of Rhode Island, the Rhode Island State Labor Relations Board held an election on March 22, 2004, by secret ballot of: All employees of the Water Department, excluding Superintendents, other Executive Officers, Supervisors and Seasonal and Temporary Employees for fewer than six (6) months.

On the basis of the election of said employees as aforesaid, Service Employees International Union, AFL-CIO, Local 134 has been designated by a majority of said employees of the Town of Jamestown, Water Department, as their bargaining representative.

That on or about April 1, 2004, a union meeting was held by the membership of Service Employees International Union, AFL-CIO, Local 134, wherein the rank and file voted overwhelmingly to have the National Association of Government Employees (NAGE), Local 5000, as their exclusive bargaining representative; resulting in a petition confirming the vote.

That on or about May 25, 2004, the duly elected members of the International Executive Board, SEIU, granted the request that jurisdiction over Local 134 be transferred to the National Association of Government Employees (NAGE), Local 5000.

That on September 9, 2004, the National Association of Government Employees (NAGE), Local 5000, submitted, to the RI State Labor Relations Board, a Consent Agreement and Affidavit, along with the appropriate documentation to acquire jurisdiction over said membership listed within Case No. EE-3672.

That on October 12, 2004, after review and discussion, the RI State Labor Relations Board accepted the Consent Agreement and Affidavit submitted by the National Association of Government Employees (NAGE), Local 5000, to become the exclusive bargaining representative of those employees contained in the bargaining unit certified in Case No. EE-3672.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that the National Association of Government Employees (NAGE), Local 5000, has become the exclusive bargaining representative of those employees contained in the bargaining unit certified in Case No. EE-3672, to wit: All employees of the Water Department, excluding Superintendents, other Executive Officers, Supervisors and Seasonal and Temporary Employees for fewer than six (6) months, as their sole representative for the purpose of collective bargaining and that pursuant to the

provisions of 28-7-16 of the Act, the National Association of Government Employees (NAGE), Local 5000, is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
