CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the RI Board of Governors for Higher Education, and the RI Federation of Teachers and Health Professionals, AFT, AFL-CIO, the Rhode Island State Labor Relations Board held an election on April 23, 2007, April 24, 2007, and April 25, 2007 by secret ballot of: Part-time faculty (all part-time employees of the RI Board of Governors for Higher Education who are employed at Rhode Island College as adjunct faculty), who teach six (6) credits within two (2) calendar years, but excluding the Applied Music Sections, Non-Credit Courses, Managerial and Supervisory employees, Confidential employees, and employees in other certified bargaining units at Rhode Island College along with their certified bargaining agent (Unions).

On the basis of the election of said employees as aforesaid, the RI Federation of Teachers and Health Professionals, AFT, AFL-CIO, has been designated by a majority of said employees of the RI Board of Governors for Higher Education as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that the RI Federation of Teachers and Health Professionals, AFT, AFL-CIO has been designated and selected by a majority of: Part-time faculty (all part-time employees of the RI Board of Governors for Higher Education who are employed at Rhode Island College as adjunct faculty), who teach six (6) credits within two (2) calendar years, but excluding the Applied Music Sections, Non-Credit Courses, Managerial and Supervisory employees, Confidential employees, and employees in other certified bargaining units at Rhode Island College along with their certified bargaining agent (Unions), as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of 28-7-16 of the Act, the RI Federation of Teachers and Health Professionals, AFT, AFL-CIO is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.




