CERTIFICATION OF REPRESENTATIVES








Pursuant to a Consent Election by and between the Rhode Island Turnpike and Bridge Authority, Service Employees International Union Local 134, and United Service and Allied Workers of RI, the Rhode Island State Labor Relations Board held an election on May 12, 2008, by secret ballot of: Plaza Supervisor, Toll Collector, Seasonal Collector, Collector/Supervisor, Maintenance Employee, Toll Collector/Maintenance Employee, and regular part-time Toll Collector, excluding the Executive Director, Director of Toll Plaza Operations, Director of Engineering, Chief of Maintenance, Director of Finance, Director of Purchasing, MIS Director, Executive Director-Secretary, all office clerical employees, and all temporary or casual employees.

On the basis of the election of said employees as aforementioned, a majority of said employees of the Rhode Island Turnpike and Bridge Authority has designated United Service and Allied Workers as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that United Service and Allied Workers of RI has been designated and selected by a majority of: Plaza Supervisor, Toll Collector, Seasonal Collector, Collector/Supervisor, Maintenance Employee, Toll Collector/Maintenance Employee, and regular part-time Toll Collector, excluding the Executive Director, Director of Toll Plaza Operations, Director of Engineering, Chief of Maintenance, Director of Finance, Director of Purchasing, MIS Director, Executive Director-Secretary, all office clerical employees, and all temporary or casual employees, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of 28-7-16 of the Act, United Service and Allied Workers of RI is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
