AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – RI Judiciary – RI Family Court, RI Council 94, AFSCME, AFL-CIO, Local 2203** and RI Laborers' District Council, Local 808, the Rhode Island State Labor Relations Board held an election on April 3, 2009, by secret ballot of: All full time and regular part time employees of the **State of Rhode Island – RI Judiciary – RI Family Court** in the following classifications: Volunteer Coordinator, Administrative Assistant, Administrative Coordinator, Deputy Clerk, Mediation Counselor, Senior Administrative Aide, Clerk Secretary, Senior Data Entry Operator, Data Entry Aide, Fiscal Clerk, Clerk Typist, excluding all other Court employees, supervisors, professionals, confidential employees, guards, seasonal and temporary employees, and other employees excluded by law.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2203** has been designated by a majority of said employees of the **State of Rhode Island – RI Judiciary – RI Family Court**, as their bargaining representative.

That on April 16, 2020, a request was received from RI Council 94, AFSCME, AFL-CIO that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **State of Rhode Island – RI Judiciary – RI Family Court and RI Council 94, AFSCME, AFL-CIO, Local 2203** and RI Laborers' District Council, Local 808.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2203** has been designated and selected by a majority of: All full time and regular part time employees of the **State of Rhode Island – RI Judiciary – RI Family Court** in the following classifications: Volunteer Coordinator, Administrative Assistant, Administrative Coordinator, Deputy Clerk, Mediation Counselor, Senior Administrative Aide, Clerk Secretary, Senior Data Entry Operator, Data Entry Aide, Fiscal Clerk, Clerk Typist, excluding all other Court employees, supervisors, professionals, confidential employees, guards, seasonal and temporary employees, and other employees excluded by law, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2203** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
