## **CERTIFICATION OF REPRESENTATIVES**

On January 11, 2011, after submission of all appropriate documentation, the RI State Labor Relations Board accepted the Petition for Affiliation/Merger between the Warwick Independent School Employees' Union (WISE) and the RI Council 94, AFSCME, AFL-CIO.

Therefore, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that the RI Council 94, AFSCME, AFL-CIO has been designated and selected by a majority of: All non-teaching personnel excluding supervisors, as defined by the Act, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16 of the Act; that the RI Council 94, AFSCME, AFL-CIO is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
