NOTICE AND DECERTIFICATION OF REPRESENTATIVES/
CERTIFICATION OF REPRESENTATIVES

Pursuant to an Agreement for a Mail Ballot Consent Election (Petition for Decertification of a Certified Bargaining Representative) by and between the University of Rhode Island Board of Trustees, URI/AAUP Part-Time Faculty United and RI Council 94, AFSCME, AFL-CIO, Local 145, the Rhode Island State Labor Relations Board held an election on April 14, 2021 by secret mail ballot of: All per course Faculty employed by the Employer at all University of Rhode Island campuses teaching a total of six (6) credits during two (2) academic years, commencing 2018 to 2019; excluding the President, the Provost, Vice Provosts, Assistant Provosts, Vice Presidents, Assistant Vice Presidents, Associate Vice Presidents, Deans, Associate Deans, Non-Union Directors, Confidential Employees, and all others excluded by the Act.

Copies of the Report Upon Secret Ballot were duly served upon all parties. No exceptions to the report of objections to the election were filed with the Board.

On the basis of the election of said employees as aforesaid, RI Council 94, AFSCME, AFL-CIO has been designated by a majority of said employees of the University of Rhode Island Board of Trustees, as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that RI Council 94, AFSCME, AFL-CIO, has been designated and selected by a majority of: All per course Faculty employed by the Employer at all University of Rhode Island campuses teaching a total of six (6) credits during two (2) academic years, commencing 2018 to 2019; excluding the President, the Provost, Vice Provosts, Assistant Provosts, Vice Presidents, Assistant Vice Presidents, Associate Vice Presidents, Deans, Associate Deans, Non-Union Directors, Confidential Employees, and all others excluded by the Act, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16 of the Act; that RI Council 94, AFSCME, AFL-CIO is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
