CERTIFICATION OF REPRESENTATIVES

That on March 28, 2022, a Consent Agreement & Affidavit was submitted by the parties, requesting a transfer of positions from EE- 3595 to EE- 3756, to wit: All Custodians and Technician/Custodians employed by the Jamestown School Department.

That on April 12, 2022, after submission and review of all appropriate documentation, the RI State Labor Relations Board accepted the Consent Agreement & Affidavit between the Jamestown School Committee and Jamestown Educational Support Professionals/NEARI/NEA and Jamestown School Facilities Support Personnel/NEARI/NEA; and therefore, the positions of Custodian and Technician/Custodian employed by the Jamestown School Department shall be transferred into the bargaining unit defined in Case No. EE- 3756, and excluded from the bargaining unit defined in Case No. EE- 3595.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that the Jamestown School Facilities Support Personnel/NEARI/NEA has been designated and selected by a majority of those employees in the class positions of Custodian and Technician/Custodian employed by the Jamestown School Department as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16 of the Act, the Jamestown School Facilities Support Personnel/NEARI/NEA is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
