CERTIFICATION OF REPRESENTATIVES


Pursuant to a Consent Election by and between the Central Falls Detention Facility Corporation and RI Council 94, AFSCME, AFL-CIO, the Rhode Island State Labor Relations Board held an election on March 1, 2023, by secret ballot of: Administrative Assistant (Programs), Counselor, Education Supervisor, Education Specialist, Electrician, General Maintenance Worker, Evidence/Grievance Coordinator, HVAC Mechanic, IT Coordinator, IT Network Administrator, IT Specialist, Key & Tool Coordinator, Legal Liaison, Lead Unit Manager, Locksmith, Maintenance Foreman Supervisor, Network Specialist, Records Clerk, Records Supervisor, Safety Manager, Unit Manager, Unit Counselor, Visitation Supervisor; excluding all other employees, professional, managerial, supervisory, and confidential, as defined by the Act.

On the basis of the election of said employees as aforesaid, RI Council 94, AFSCME, AFL-CIO has been designated by a majority of said employees of the Central Falls Detention Facility Corporation, as their bargaining representative.


THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that RI Council 94, AFSCME, AFL-CIO, has been designated and selected by a majority of: Administrative Assistant (Programs), Counselor, Education Supervisor, Education Specialist, Electrician, General Maintenance Worker, Evidence/Grievance Coordinator, HVAC Mechanic, IT Coordinator, IT Network Administrator, IT Specialist, Key & Tool Coordinator, Legal Liaison, Lead Unit Manager, Locksmith, Maintenance Foreman Supervisor, Network Specialist, Records Clerk, Records Supervisor, Safety Manager, Unit Manager, Unit Counselor, Visitation Supervisor; excluding all other employees, professional, managerial, supervisory, and confidential, as defined by the Act, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of 28-7-16 of the Act, RI Council 94, AFSCME, AFL-CIO is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


