**CONCLUSIONS:** The Union has not proven by a preponderance of the evidence that the Employer committed a violation of R.I.G.L. § 28-7-13 (5), (8) and/or (10) when it held a press conference on October 1, 2024 and discussed various matters, including employee disciplinary and personnel matters that referenced members of the Union in a generic manner.

**ORDER:** The above-entitled matter is hereby dismissed.
